



Bus Driver Training Class 2 Driver Training July 25 - September 2, 2022

The Bus Driver Training Program is being offered in partnership with School District 28. The training will be conducted on an automatic transmission school bus with professional driving Instructors. In addition to ICBC road test preparation and pre-trip training, students will acquire airbrakes ticket and the necessary skills required to safely transport passengers.

Driving a bus in a professional capacity requires specialized skills for the safe transportation of people of all ages. Whether you are driving a school bus, transit bus or motor coach, our Bus Driver Training Program will ensure you conduct yourself in a safe and professional manner.

Application Process:

1. Submit CE Registration form and submit Driver's Abstract to CNC Quesnel
2. Take Conditional Letter of Acceptance to funding organization if seeking sponsorship
3. When funding is approved, submit confirmation letter to CNC
4. Class 2 Learner's License exam (knowledge test paid for by CNC)
5. Acceptance into program

Note: A Driver's Medical Exam will be required prior to your road test. (Exam fee paid for by CNC)

Potential employers require the following:

- *Grade 12 or equivalent*
- *Criminal Record Check*
- *OFA Level 1*

Program Components

Class 2 Driver Training & Airbrakes

Designed for a student with no or minimal knowledge. Includes Airbrake endorsement and ICBC road testing.

You will learn:

- Pre-trip inspection
- Driving
- Reversing
- Safely transporting passengers

Mentoring & Training

School District 28 will provide mentorship and hands-on training. Participant will be partnered with a qualified experienced mentor who will provide mentorship and training over a 2-week period.

The objectives of the mentorship:

- Develop drivers that are qualified and competent (skills, knowledge and attributes)
- Improve safety in the sector

British Columbia School Bus Driver Training Program

The BC School Bus Driver Training Program is run through the Association of School Transportation Services of BC. Participants successfully completing this training will be certified by the Motor Carrier Passenger Council of Canada.

Modules covered in this training include:

- Introduction to Responsibilities and Safety
- School Bus Inspection and Maintenance
- Attitude
- Driving a School Bus
- Loading and Unloading Students
- Student Relations and Management
- Emergencies, Bus Evacuations, Emergency Equipment and First Aid
- Transporting Students with Disabilities
