

APA Citation 7th ed.

Basics

- APA, 7th ed., bases its reference on the **four elements.** The four reference elements answer four questions: **Author Who? Date When? Title What? Source Where?**
- Double-space your reference entries (including between and within the references) in your Reference list and you can find examples at the end of the document.
- You can display the DOI and URLs as default hyperlinks (blue font and underlined) or plain text without blue front and underline in your References list
- A DOI or digital object identifier is a unique alphanumeric string that identifies content and provides a persistent link to its location on the internet. If the work has a DOI, you should include it in your citation. Format the DOI as an URL starting with https://doi.org/ and you can find the References page at the end for examples. You might find the DOI on the works information page on the library database or inside the work itself. If you are unable to find DOI, you might be able to find it through https://www.crossref.org, clicking on search metadata tab, and pasting the title of the work. If the work does not have a DOI, you should format the reference entry as a print work.

Write the publisher's name as shown in the work, followed by a period. Do not include designations of business structure (e.g., Inc., Ltd.) in the publisher name.

Three authors or more

If there are three or more authors, include the name of only the first author plus "et al." in every citation, including the first citation.

Work with 21 or more authors (print or eBook from library database)

For a work with 21 or more authors, include only the first 19 names and three ellipses... and the final name in the reference. For in-text citations, include the name of only the first author plus "et al." as above.

Page numbering

Many electronic resources do not include page numbers. The APA manual stresses that it is important to provide readers with ways of locating a quoted passage. Here are some tips for all page numbering

Rogers, 2009, **p. 275** ← a page, if identified

Rogers, 2009, **pp. 275-310** ← *multiple pages*

Rogers, 2009, **para. 5** ← a paragraph in an electronic source that has no other paging

Rogers, 2009, paras. 5-6 ← multiple paragraphs

Rogers, 2009, **Arthritis section** ← a section of the content

Rogers, 2016, **Conclusion section, para. 1** ← a more specific part of the section

Rogers, 2016, Chap. 3 ← chapter 3 of an eBook

Since the Wikipedia entry title is not italicized in the reference entry, the intext citation will have double quotations mark around it. Additionally, we can shorten the title if it is too long.

Unpublished, unrecoverable personal communication are not included in the reference list because they do not provide recoverable data. Cite the lecture only in the body of your paper.

Quotations

Material directly quoted from another author's work should be reproduced word for word. Include a quotation that is less than 40 words as part of the text and enclose the quotation with double quotation marks. Quotations must include author's name, year and page numbers.

Short Quotations (less than 40 words) of one work by one author

She stated, "The 'placebo effect' ...disappeared when behaviors were studied in this manner" (Miele, 1993, p. 276), but she did not clarify which behaviors were studied.

Or

Miele (1993) found that "the 'placebo effect,' which had been verified in previous studies, disappeared when [only the first group's] behaviors were studied in the manner" (p. 276).

Long quotation (over 40 words)

If a quotation contains 40 words or more, treat it as a block quotation. Do not use quotation marks to enclose the block quotation. Start a block quotation on a new line and indent it fives spaces from the left margin. Type subsequent lines flush with the indent. Double-space the entire block quotation. At the end of the block quote, cite page number of the source in parenthesis after the final punctuation mark. If the author date information has not been included in the text of the essay prior to the block indentation, they must be given after the final punctuation of the quote.

Secondary Sources

Whenever possible, refer to an original source and not a secondary source. If only a secondary source is available, in the rest of your essay use "as cited in" to refer to the secondary source. In the References list, only the secondary source is listed.

In-Text: In Warkinton's study (as cited in Roberts, 2020), children's cognitive growth and development...

Or

Roberts (2020) examined Warkinton's study on children's cognitive growth and development...

Roberts, M. (2020). Children, cognition, and the development of language. *Psychological Reports*, *19*(7), 412-419.

Order of Multiple Works by the Same First Author

One-author entries should be arranged by year of publication, the earliest first. References with no date precede references with dates.

Smith, K. (n.d.). Smith, K. (2015). Smith, K. (2021a). Smith, K. (2021b).

Multiple Works by the Same First Author with no Date

Taylor, A. (n.d.-a). Taylor, A. (n.d.-b).

No Author

If no author or creator is provided, start the citation with the title/name of the item you are citing instead. Follow the title/name of the item with the date of publication, and then continue with other citation details.

Note: an author/creator will not necessarily be a person's name. It may be an organization or corporation, for example Health Canada or a username on a site such a YouTube.

In-Text

If no author or creator is provided, use a shortened version of the title where you would normally put the author's last name.

If you are citing something, which is part of a larger work, like an article from a magazine, newspaper, journal, chapter or short story from a book, put the shortened title in quotation marks in your in-text citation.

In-Text Paraphrase: ("A few words", 2018)

If you're citing an entire work, like a book, website, video, etc., italicize the shortened title in your in-text citation

In-Text Paraphrase: (A few words, 2018)

PowerPoint slides

If the slides come from a classroom website or learning management system and you are writing for an audience with access to that resource, provide the name of the site and its URL (use the login page URL for sites requiring login).

Video & DVDs

The director should be credited as the author of the film. If the director is unknown, someone in a similar role can be credited instead. The format or other descriptive information may be added after the title in square brackets.

Traditional Knowledge or Oral Traditions

If you spoke with an Indigenous person directly

Provide the person's full name and the nation or specific First Nations group to which they belong, as well as their location or other details about them as relevant, followed by the words "personal communication", and the date of the communication.

Ensure that the person agrees to have their name included in your paper and confirms the accuracy and appropriateness of the information you present

We spoke with Darlene McIntosh (Lheidli T'enneh Nation, lives in Prince George, British Columbia, Canada, personal communication, March 2020) about traditional understanding of the world by First Nations Peoples in Canada. She described...

If you are a First Nations person and are sharing your own experiences or the previously unrecorded Traditional Knowledge or Oral Tradition of your people, describe yourself in the text (e.g., what nation you belong to, where you live) to contextualize the origin of the information you are sharing. Do not use a personal citation or provide a reference list entry because you do not need to cite personal information.

Setting up essay pages and formatting tips

Paper: normal letter size paper, type on one side only, double-space.

Margins: 1" (2.54 cm) all round, right margin not justified.

Title and paging: On main Title page include the **full title of your paper in bold**, your name, the institution name, course name, instructor name and due date of paper. Pagination begins in top right corner.

Font: Use the same font throughout the text of the paper. Font options include: 11-point Calibri, 11-point Arial, 10-point Lucida, 11-point Georgia, 12-point Times New Roman. Confirm with your instructor their preferred font.

Paragraph indentation: Indent the first line of every paragraph 0.5 in. For consistency, use the tab key. The remaining lines of the paragraph should be left-aligned.

On the References page: List in alphabetical order of the sources you used in your essay.
