

Using Vancouver Style





General Information

The Vancouver style is a preferred style guide in the fields of Medicine, Physical and Occupational Therapy and other allied health fields. At CNC, it is used primarily in Dental and Med Lab Tech programs. Vancouver Style is a brief name for the Uniform Requirements for Manuscripts Submitted to Biomedical Journals and which works on the same principles as the *National Library of Medicine Recommended Formats for Bibliographic Citation*.

General Formatting

Spacing

Double space all portions of the manuscript— including the title page, abstract, text, acknowledgments, references, individual tables, and legends.

References

The following information provides an overview of the various acceptable ways of organizing references, according to the Introduction of *Citing Medicine: The NLM Style Guide for Authors, Editors and Publishers.*

References are presented in two ways in medical publications. At the end of a journal article, book, or book chapter, all of the references that contributed to the work are presented in a list called *references, end references, literature cited*, or *bibliography*.

References – or – End References – or – Literature Cited

at the end of your paper, a list of sources you have referred to in the text, arranged by number or author *Bibliography* – or – Additional References

- at the end of your paper, following the *References* list or just as a stand-alone list arranged by author, these are sources you have not referred to in the text of
- your paper but that are relevant to your subject

In-Text References

in the text of your paper, present individual references ("in-text references") in an abbreviated format - by number, in brackets or in superscript - or by name-year – directing readers to the above list(s).

Citation-sequence

In the <u>citation-sequence system</u>, numbers are used to refer to the reference list. References are numbered in the list in the order they first appear in the text. For example, if a reference by Zelinski is the first one referred to in the text, then the Zelinski reference is number one in the list. If a reference is used again, the original number is re-used.

Dental students will always cite in text with either a bracketed number or a superscript number and the reference list will be in numerical order as references appear in the cited text.

<u>Elements of citation:</u> Author Surname Initials, editors. Title of book. Place of publication: Publisher; Date.

Optional – Relating to number of author names:

Give all authors/editors, regardless of the number, but if space is a consideration, the number of authors may be limited to a specific number, such as the first three authors. Follow the last named author by a comma and "et al."

Optional addition – Relating to secondary author names:

A secondary author modifies the work of the author. Examples include editors, translators, and illustrators. Place the names of secondary authors after the title, following any Content Type, Type of Medium, or Edition statement

Book with no Author, Editor, or Translator

If no person or organization can be identified as the author and no editors or translators are given, begin the reference with the title of the book. Do not use anonymous.

<u>Elements of citation:</u> Title of book. Edition. Place of publication: Publisher; Date.

Chapter in a book

Chapters, sections, tables, charts, graphs, photographs, appendices, and the like are considered parts of books when they are written or compiled by the authors of the book. They are contributions when the book has an overall editor or editors and the individual chapters or other components in the book are written by various authors, usually called contributors. In general, most modern texts have standardized to three types of parts: figures, tables, and appendices. However, other names may be found for parts, including section, chart, graph, box,

Begin a reference to a part of a book with the book itself, then follow it with information about the part.

Elements of citation:

Author Surname initials. Title of book. Edition. Place of publication: Publisher; Date. Chapter number, Chapter title; pagination.

Figure in a book

Elements of citation:

Author Surname initials. Title of book. Edition. Place of publication: Publisher; Date. Figure number, Figure title, pagination.

Table in a book

Elements of citation:

Author Surname initials. Title of book. Edition. Place of publication: Publisher; Date. Table number, Table title, pagination.

Burant CF. Medical management of type 2 diabetes. 5th ed. Alexandria (VA): American Diabetes Association; 2004. Table 3.12, Sample regimens for achieving glycemic control; p.68.

Contribution to a book (essay in anthology)

Contributions are found when a book has an overall editor or editors and the individual chapters or other components of the book are written by various authors, usually called contributors. One or all of the editors may also be contributing authors. Because a reference should start with the individual or organization responsible for the intellectual content of the publication, begin a reference to a contribution with the author and title of the contribution, followed by the word "In:" and information about the entire book.

Elements of citation:

Contributing Author Surname Initials. Title of essay or contribution. In: Editor Surname Initials, editors. Title of book. Place of publication: Publisher; Date. Pages of essay or contribution.

EXAMPLES - Journal Articles, Paper format

Journal titles:

 Journal titles are abbreviated (with the exception of single word journal titles, e.g. Urology) – see abbreviations in "Check List of Serials and Abbreviations" or "National Library of Medicine List of Journals Indexed for Medline" on library citations page

- Abbreviate and capitalize significant words in a journal title and omit other words, such as articles, conjunctions, and prepositions. For example: of, the, at, in, and, L' (French for "The")
- Add a period at the end of the journal title abbreviation
- The Journal of Biocommunication becomes J Biocommun.

Optional – Relating to Journal names:

The following forms are acceptable options:

- Periods may be placed after each abbreviated word in the title, e.g.
 - J Contin Educ Nurs. may become J. Contin. Educ. Nurs.
- □ The title may be written out in full, e.g.

Journal of Continuing Education in Nursing.

The user should be consistent in applying them throughout a reference list. For example, if the full journal title is used instead of the title abbreviation in one reference, it should be used in all journal article references.

Page numbers:

- Give the inclusive page numbers on which the article appears
- Do not repeat page numbers unless they are followed by a letter. For example: 123-125 becomes 123-5, but 124A-126A is correct.
- Include a letter (often S for Supplement or A for Appendix) when it precedes the page number. For example: S10-8.

EXAMPLES – Journal Articles, Online

Journal article on the Internet: not from a library journal database

- Cite an Internet journal article as you would a print article, but with these major exceptions:
- Use the word "Internet" in square brackets as the *Type of Medium* after the journal title. [Note: See the option at Nomura example below]
- Include any date of update/revision and a date of citation in square brackets following the date of publication. Use the dates for the individual journal article being cited, not the dates of the journal issue as a whole unless no dates can be found for the individual item.
- When the location (pagination) of the article is not provided, as often occurs, calculate the length of the article using the best means possible, e.g. in terms of print pages, screens, paragraphs, or bytes. If an article is not linear, and has many hyperlinks, it will be impossible to determine the length.
- Provide the URL or other electronic address of the article. End with a period only if the URL ends with a slash (e.g. http://www.abc.com/. period – http://www.telus.net/bin.htm no period). The URL can be followed by a DOI Digital Object Identifier if available (see example 20)
- □ If information is known regarding access to the article, such as whether a subscription is required to view or free full text is available, note whether a subscription is required, or if it is free full text.
- It is important to cite the version you saw. If you viewed an article on the Internet, do not cite it as if it were a print one. However, it may be useful to begin a citation to an Internet article by first locating all of the information needed to cite it as if it were a print article, then adding the Internet-specific items. For example:

Journal article on the Internet - updated/revised after publication

Journal article on the Internet that has a unique identifier, e.g. Digital Object Identifier (DOI) such as a PubMed ID (PMID) or PubMed Central ID (PMCID)

The DOI or Digital Object Identifier was developed by the International DOI Foundation (http://www.doi.org/) to provide for persistent identification of documents across networks. It does this using a naming convention consisting of a prefix that contains the name of the particular DOI directory and the content owner's identifier, and a suffix that is a numeric or alphanumeric string supplied by the publisher.

Publishers register with the International DOI Foundation to obtain their owner's identifier, then submit their suffix to a DOI registration agency along with the URL and appropriate metadata for the particular document being registered.

Many publishers are currently assigning DOIs at the article level. Some assign one DOI to an article regardless of changes in edition or format, while others give a unique DOI to each version.

To find an article on the Internet using its DOI, add the prefix "http://dx.doi.org/" to the number. To use a DOI in a citation:

- Begin with DOI followed by a colon and a space
- Enter the number supplied by the publisher

Journal articles on the Internet: From a library database

Examples of Citations to Contributions to Databases on the Internet:

- Contributions are separately identified records, sections, or other portions of Internet databases that are provided by individuals or organizations other than the database builders. They thus have distinct authorship.
- There are two types of contributions: those written expressly for the database, such as a review produced for the Cochrane Database of Systematic Reviews, and those written for a primary publication such as a journal or book that is cited in the database. A journal article in a bibliographic database such as PubMed is an example of the latter. The first type of contribution contains only an author and title, and sometimes a date of publication; it has no place of publication, publisher, or other publication information separate from the database. The second type, however, contains full publication information.
- A reference should start with the individual or organization with responsibility for the intellectual content of the publication. Begin a reference to a contribution with information about the contribution, followed by the word "In:" and information about the database.

Article author Surname Initials. Title of article. Title of journal, abbreviated. Year Month date [cited year month date];vol#(issue#):pages of article. In: Database Name [Internet]. Available from: basic web address or optional complete web address. Optional addition of a database's unique identifier number for the citation.

□ Cite components of Web sites that cannot stand alone according to this model. For example, if the MedlinePlus site puts up a disease page (written by MedLine Plus staff) – or the AMA site puts out a press release (written by the AMA) – then the main website is the 'author'

Title of MAIN homepage [Internet]. City of publication (or province/state/country of publication): Publisher; c years of copyright. Title of part of website; Date of publication of part of website [cited date]; [number of pages or screens]. Available from: URL

Parts of a website – when authorship is distinct – e.g. an opinion piece, an essay, a book

If a component of a website has a distinct author, it can stand alone. Cite it according to the instructions for the particular type of format. For example, this shows how you would cite an opinion piece, essay or book posted on a webpage. Other examples would be a *journal* and a *database*. If in doubt about the status of a component, cite it separately.

Elements of Citation – opinion piece, essay etc.:

Author(s). Title of opinion piece, essay, etc. [Internet]. Date of publication of part [Date of citation]; Extent. Available from: URL.

- Place the word Video, Videocast, or Podcast in square brackets before the title
- Follow it with a comma and a space
- Enter the length of the item (number of minutes needed to view/listen) in square brackets after the date of citation

Direct quotes are to be used sparingly – If a direct quote is necessary, place quotation marks around the quote and number the reference as usual (see number 6 in the example below)

Even when recommendations come from such rigorous approaches, however, "it is important to differentiate between those based on weak vs. strong evidence" (6).

Tables

- Type or print each table with double spacing on a separate sheet of paper.
- Number tables consecutively in the order of their first citation in the text and supply a brief title for each.

Example:

Footnotes

- Place explanatory matter in footnotes, not in the heading. Explain in footnotes all nonstandard abbreviations.
- For footnotes use the following symbols, in sequence: *,†,‡,§,||,¶,**,††,‡‡

Illustrations/Figures

- Figures should be numbered consecutively according to the order in which they have been first cited in the text.
- If a figure has been published, acknowledge the original source copyright holder. Permission to reproduce the material is required irrespective of authorship or publisher except for documents in the public domain.

Helpful Hints:

- Follow Canadian cities with the two-letter abbreviation for the name of the province placed in parentheses; for example: Vancouver (BC).
- For cities in other countries, if the city is not well known or could be confused with another city
 of the same name, follow the city with the country name, either written in full or as the twoletter ISO country code. Place the country name or code in parentheses. For example:
 Oxford (England): or Oxford (GB): As an option, use the country name or country code after
 all cities not in the US or Canada, for example Vienna (Austria).
