# Prior Learning Assessment and Recognition (PLAR)

## **Policy Statement**

College of New Caledonia values student learning and the rich variety of ways and environments in which learning takes place. The College seeks to provide recognition of previous traditional and non-traditional learning. When such learning is not recognized by formal transfer agreements, it may be recognized through Prior Learning Assessment and Recognition (PLAR).

#### **Purpose / Rationale**

The purpose of this policy is to ensure a systematic and consistent process for recognizing a person's knowledge, skills and abilities for academic credit. This policy also outlines assessment methods and recognition credits available through PLAR at the College.

#### **Scope / Limits**

This policy applies to all College of New Caledonia students requesting formal assessment of their prior learning for college level credit towards a specific program requirement that are PLAR eligible.

Specific courses may be excluded from PLAR based on program requirements.

## **Principles/Guidelines**

- 1. Students will receive credit for demonstrated knowledge, skills and attributes, and not for experience or time spent alone.
- 2. Credit will be awarded only for equivalent of post-secondary level learning.
- 3. The assessment and recognition of prior learning and the determination of credit awards will be made by subject matter and academic experts.
- 4. CNC reserves the right to determine a course's eligibility for PLAR.
- 5. Formal credit for learning that has been assessed as equivalent to College of New Caledonia courses and programs is granted as follows:
  - 5.1. It is given a grade of Prior Learning Assessment "PL" which is recorded on the college transcript and is not calculated into the College GPA; Unsuccessful PLAR will be recorded in a student's record, but not shown on the college transcript.

- 5.2. It is considered College of New Caledonia resident credit. However, the maximum number of credits that can be awarded through the PLAR process is defined by the program area in which the PLAR credits will be used and may not exceed 50% of the credential.
- 6. Students will request or be requested to document their learning of specific knowledge, skills and values related to the course or program learning outcomes, objectives or competencies for which credit is requested. Documentation must support learning and may include, but is not limited to one or a combination of the following assessment types:
  - 6.1. Challenge Examination
  - 6.2. Portfolio Assessment
  - 6.3. Work-based Assessment
- 7. PLAR credit will be awarded only to those students who have been admitted into a College of New Caledonia credit program.
- 8. A request for a PLAR may be denied or delayed under the following situations:
  - 8.1. The course has not been identified as being eligible for PLAR.
  - 8.2. A qualified subject matter and academic expert is not available to complete a PLAR.
  - 8.3. The student's prior experience/learning is not deemed adequate to achieve a reasonable expectation of success in meeting the course(s) learning objectives/outcomes as determined by the Department Educational Administrator or Designate.
- CNC accepts credit earned through PLAR (as transfer credit) from all Canadian accredited post-secondary institutions that have formally adopted quality assurance standards from a recognized organization such as the Council for Adult and Experiential Learning, the European Union or UNESCO. Such transfer credit is applied in the context of CNC course and program requirements.
